## 2. HAZARDS IDENTIFICATION

### A. EMERGENCY OVERVIEW:

**Physical Appearance and Odor:**

off-white to pale yellow waxy solid, aromatic odor.

### 4. FIRST AID MEASURES

**Handling:**

Avoid breathing vapors and mists. Avoid direct or prolonged contact with skin and eyes. Low pressure steam or a water bath may be used to melt solidified material. Product is a solid at ambient temperature. If it is handled as a liquid, there is significant hazard of 1st, 2nd and 3rd degree burns.

Ethylene oxide may collect in container head space. Although concentrations are expected to remain below

established exposure limits, provide adequate ventilation when accessing or working with open containers and tanks.

**Storage:**

Store in tightly closed containers. Store in an area that is dry, well-ventilated, away from ignition sources, away from incompatible materials (see Section 10. Stability and Reactivity).
