Avoid breathing vapors and mists. Avoid direct or prolonged contact with skin and eyes. Use nonsparking tools and grounded/bonded equipment and containers when transferring. In cold weather, this product may stratify and freeze. This does not damage the product. If freezing occurs, thaw and remix before using. Frozen material may be thawed in a warm room. Avoid localized overheating. Vent drums while heating. Mix thoroughly to assure homogeneity.

Ethylene oxide may collect in container head space. Although concentrations are expected to remain below established exposure limits, provide adequate ventilation when accessing or working with open containers and tanks.

Storage:
