7. HANDLING AND STORAGE

Handling:

Avoid breathing vapors and mists. Avoid direct or prolonged contact with skin and eyes. DO NOT ALLOW TO FREEZE. A hot water bath may be used to melt solidified material.

Ethylene oxide may collect in container head space. Although concentrations are expected to remain below established exposure limits, provide adequate ventilation when accessing or working with open containers and tanks.

Storage:

SHIP AND STORE ABOVE 40F. Store in tightly closed containers. Store in an area that is dry, well-ventilated, away from incompatible materials (see Section 10. Stability and Reactivity).
